## Assistant First Team Physiotherapist / Sports Therapist (Full Time)

Contract: Full Time / Prepared to work weekends and evenings, when required.

Place of work: Brunton Park, Warwick Road, Carlisle but may on occasions be based at other training venues within

Carlisle United Football Club are looking to recruit a highly motivated individual to work with our First Team Management and Players.

Hours will be based around the weekly training schedule and fixtures, but will involve working evenings, weekends and match days so a flexible work approach is required.

### Key responsibilities (but not limited to):

Reporting to the Head Physiotherapist the successful candidate will provide the highest standard of physiotherapy services to the first team players ensuring the delivery of accurate and effective assessments, diagnosis and management of injuries.

- Design and delivery of gym and pitch-based rehabilitation for injured first team players.
- Pre training management of players including strapping and taping and administration of treatment as required.
- · Implement injury prevention strategies in conjunction with other medical staff.
- Close liaison with the Head Physiotherapist, Club Doctors, Strength & Conditioning Coaches and other members
  of the multidisciplinary team to optimise player medical care and performance.
- Delivery of individual and squad-based injury prevention programmes based on screening, past medical history and injury trends.
- Assisting with pre-signing medicals as and when required.
- Assist with pre-season medical and concussion screening of all first team players.
- Implementing strategies to maximise player performance on the football field from a medical perspective.
- Helping to mentor medical department interns and students.
- Arrange consultations with medical personnel and any relevant investigation related to an injury e.g. MRI scan, X-ray appointments and coordinate any other forms of specialist treatments. Accompanying players to appointments as and when required.
- Complete comprehensive, accurate, reliable and confidential medical records for all professional players.
- Provide medical cover for first team training sessions, as well as first team home games and away games as and when required.
- Provide medical cover for reserve games home and away as and when required.
- Assist with submission of weekly doping control schedules ensuring compliance is met at all times.
- Be involved in clinical governance and maintain professional registration.
- · Assist with stock checking and ordering of medical supplies and equipment.
- Assist in the packing and organisation of medical kit and equipment for away games.
